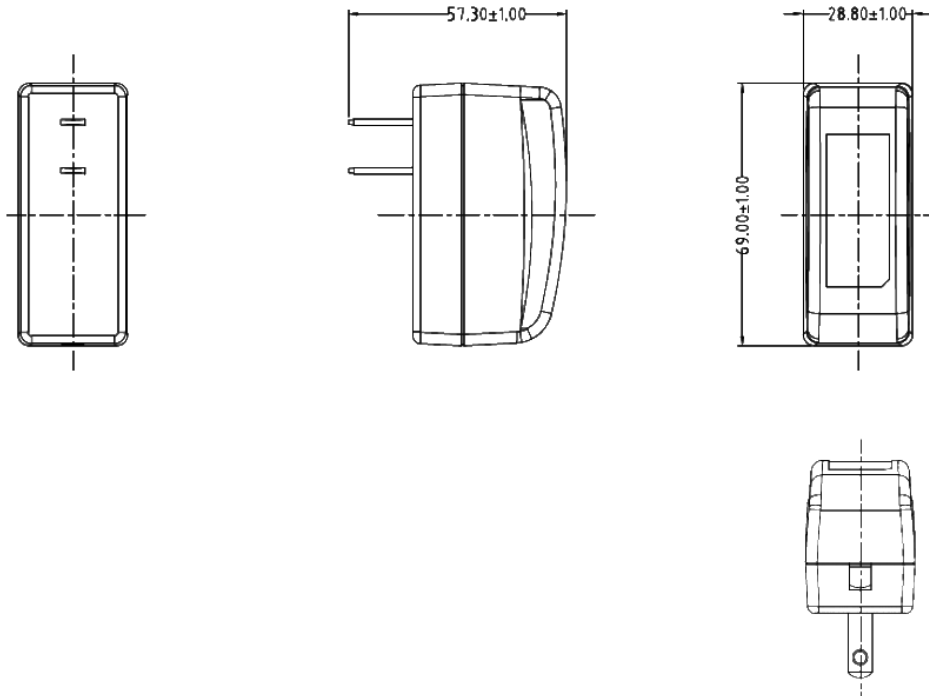

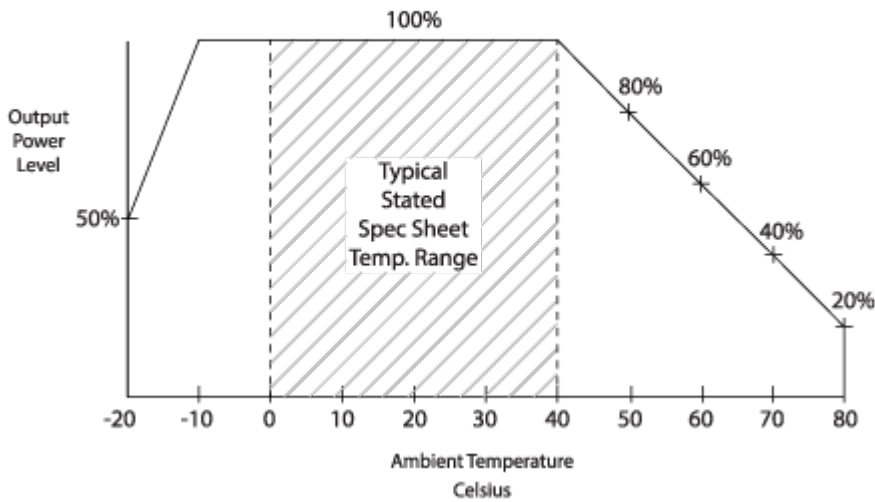

DERATING CURVE

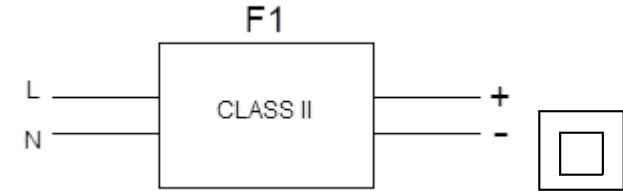
**Typical External
