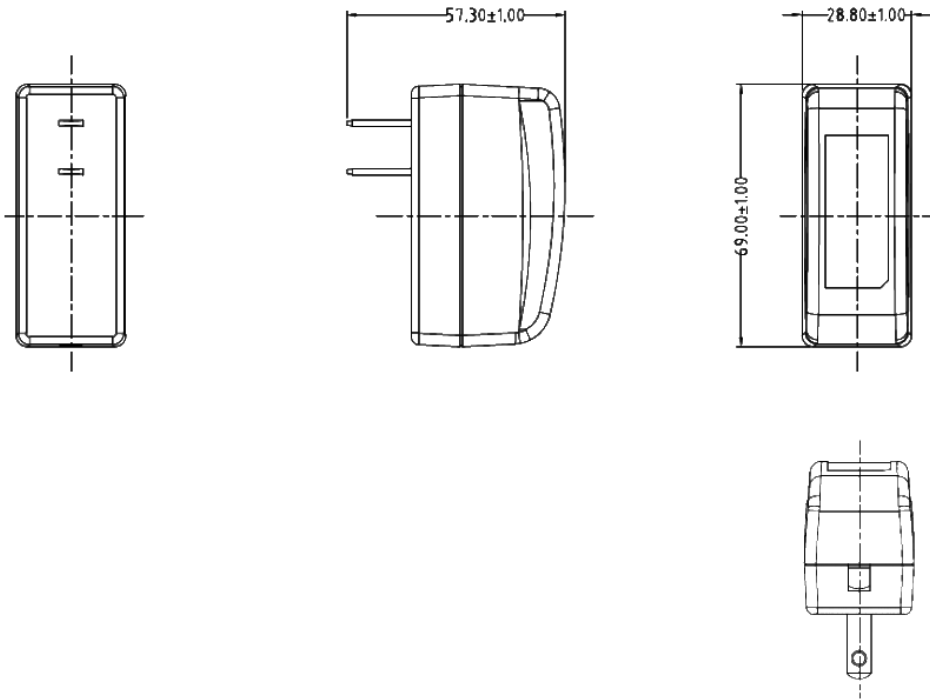

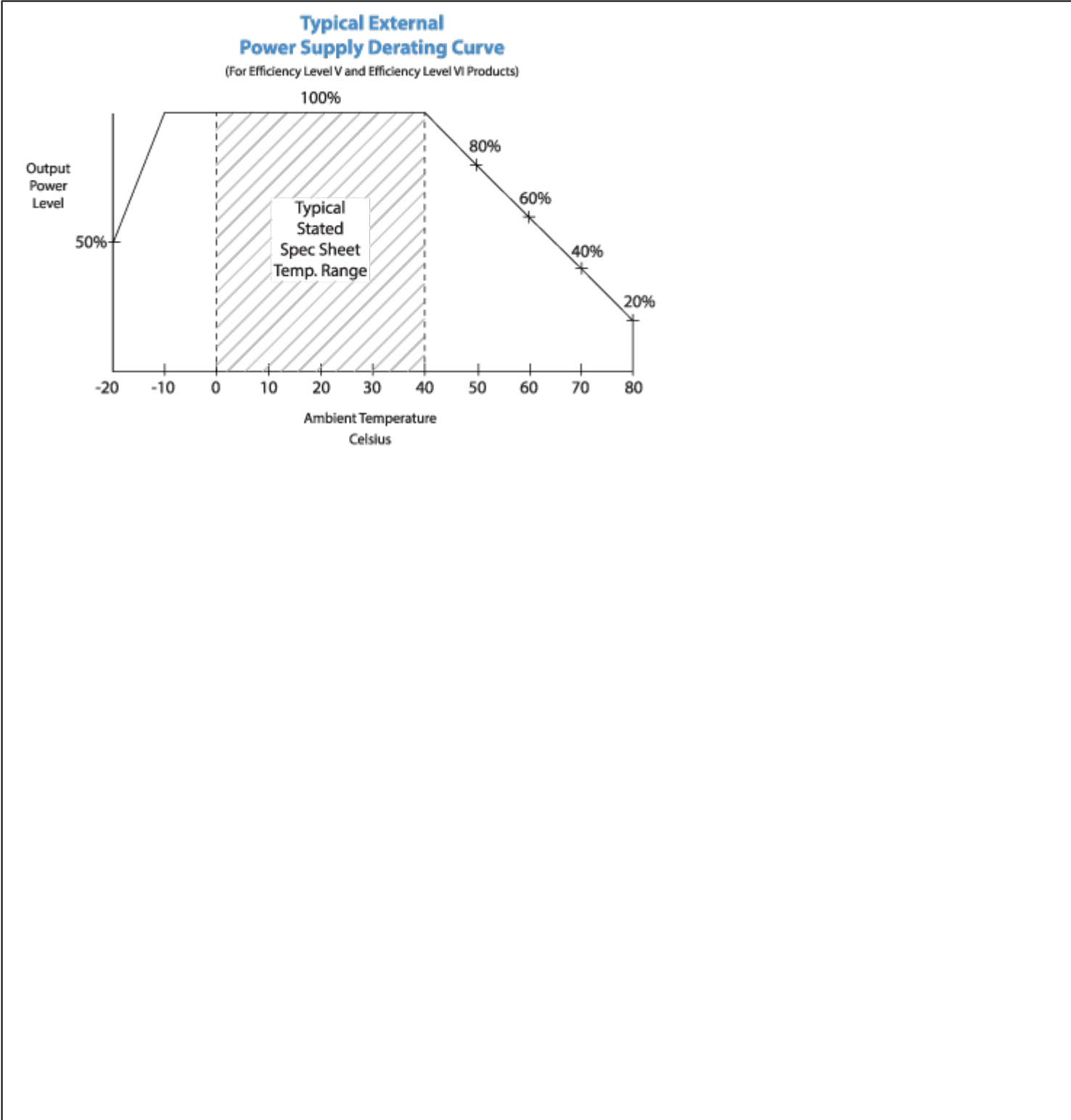

DERATING CURVE

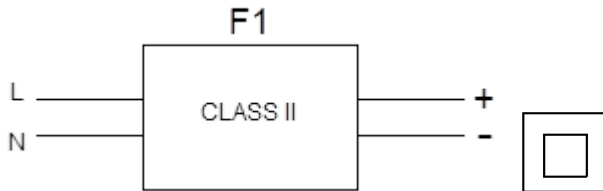
