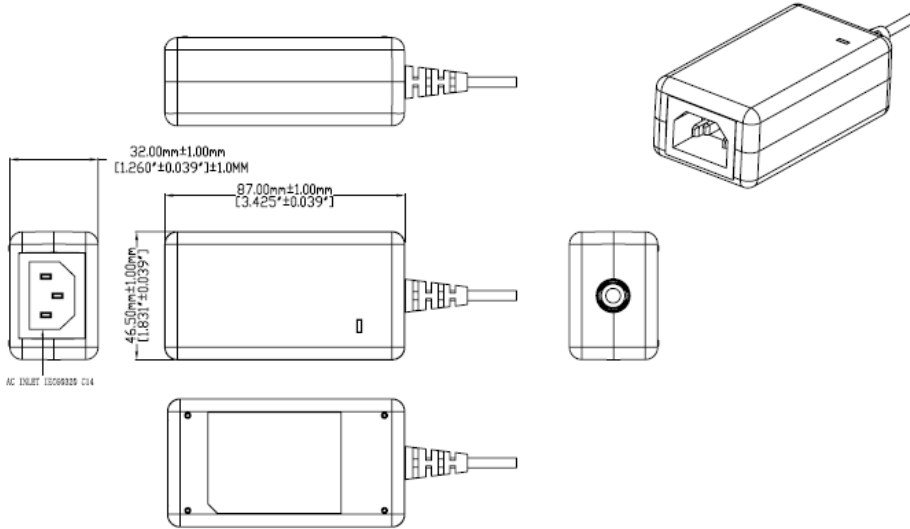

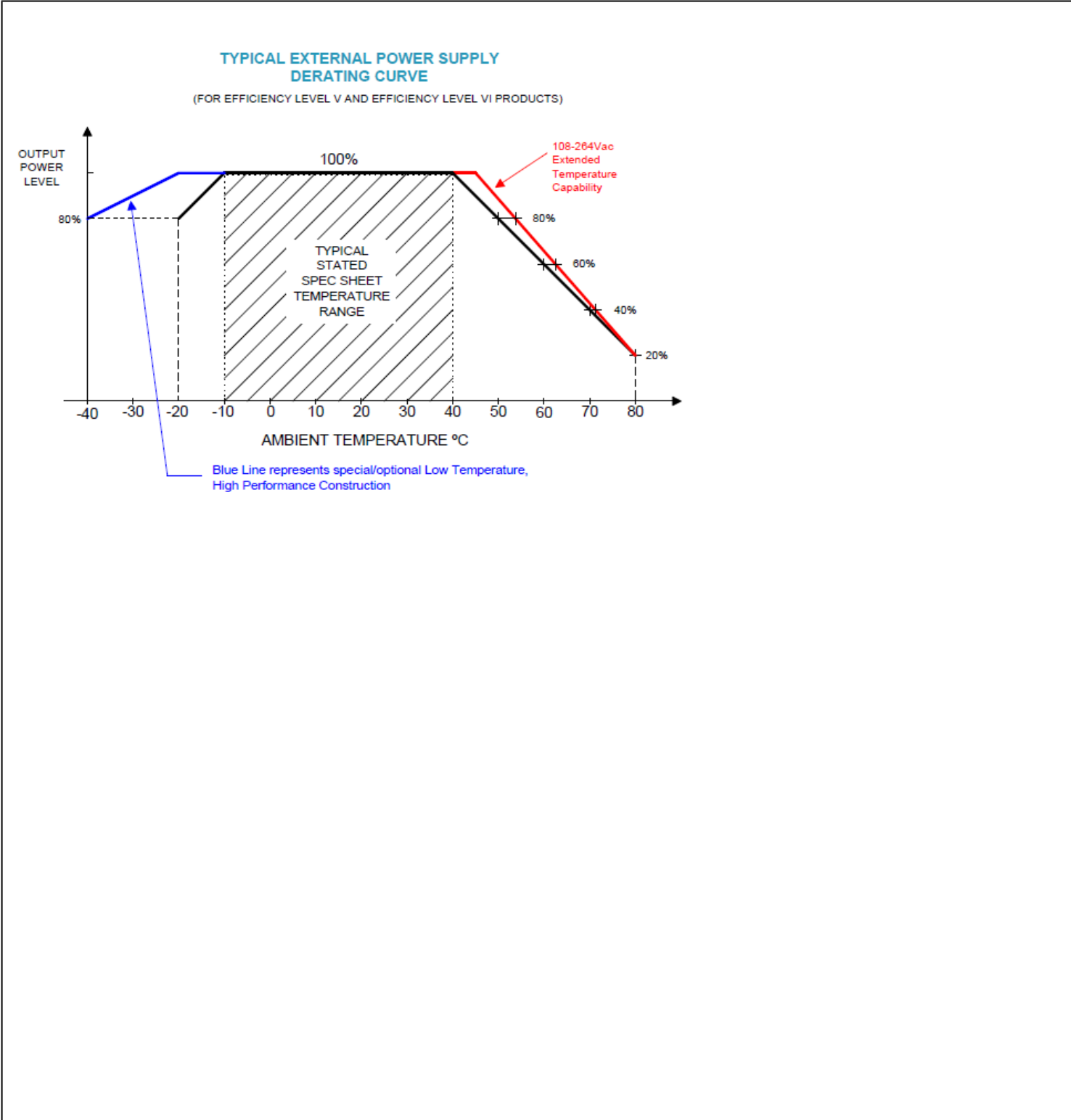

DERATING CURVE

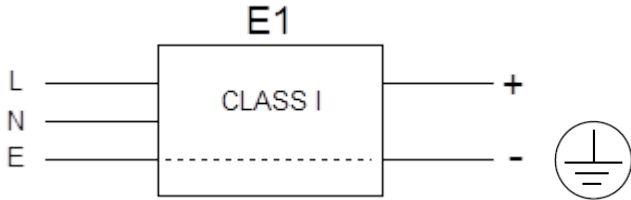
