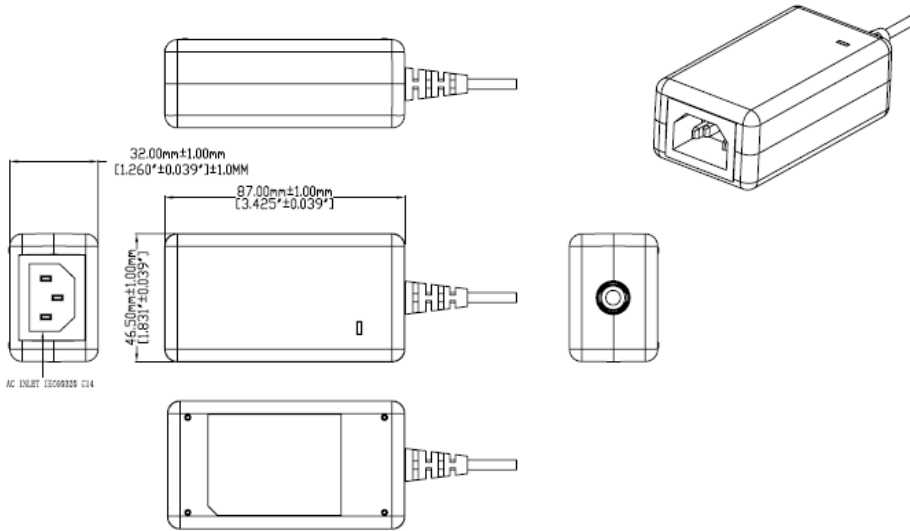

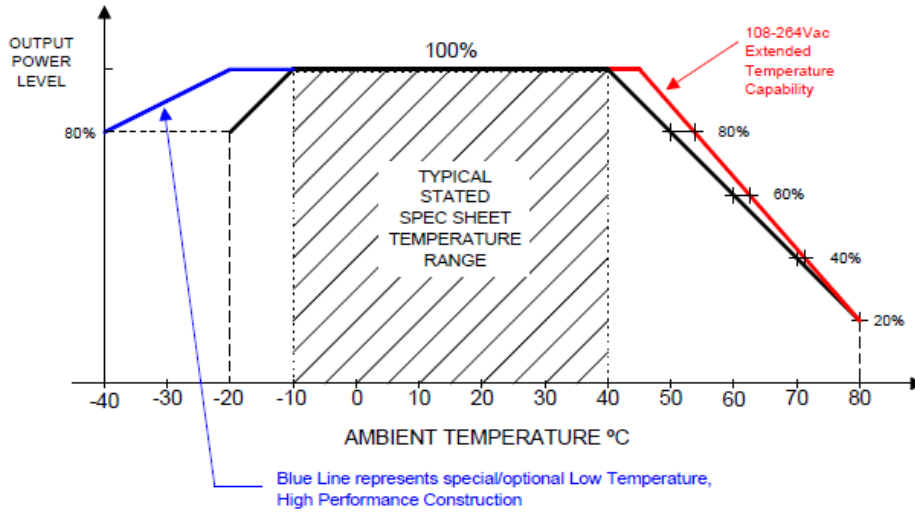

 DERATING CURVE**

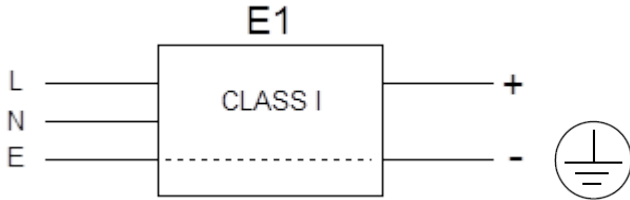
