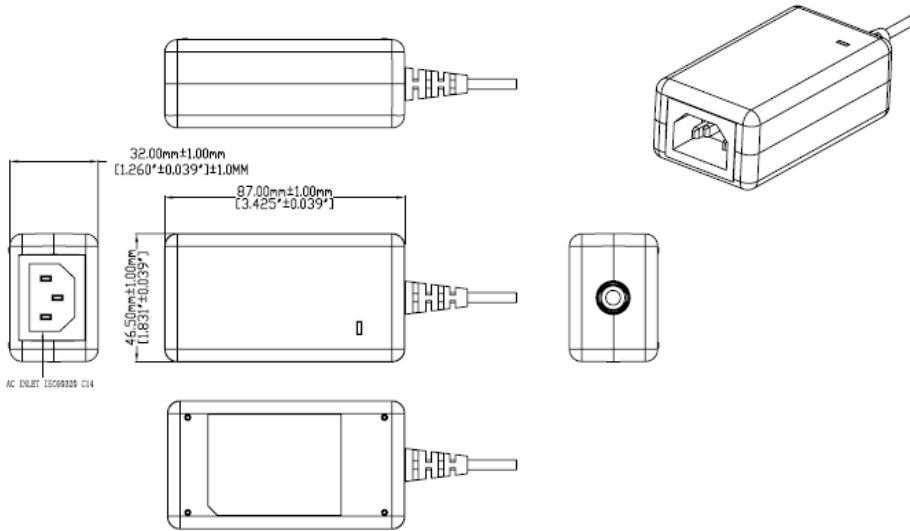

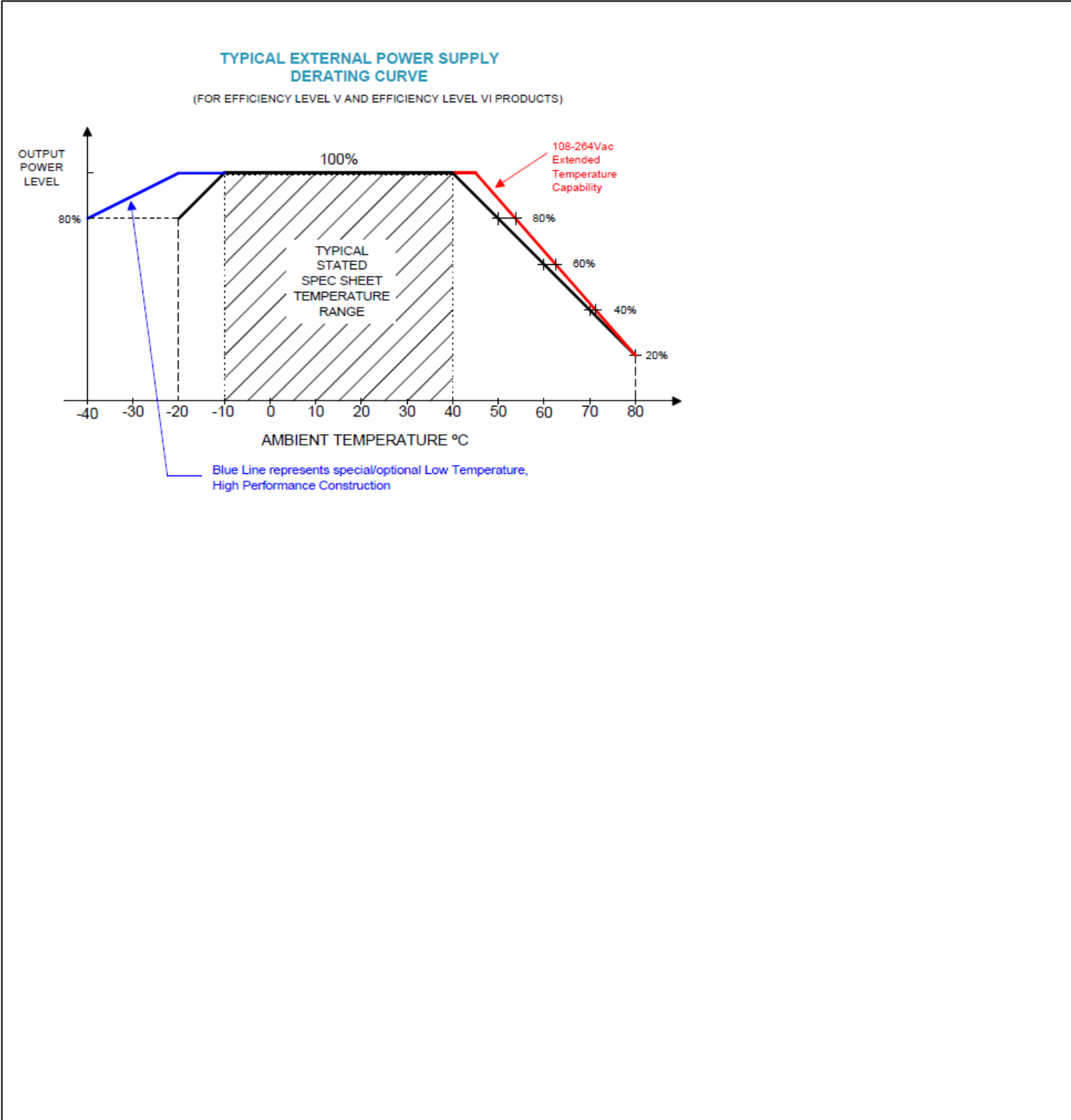

DERATING CURVE

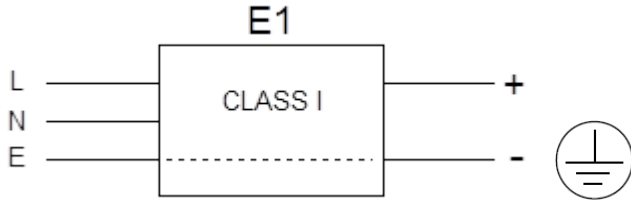
