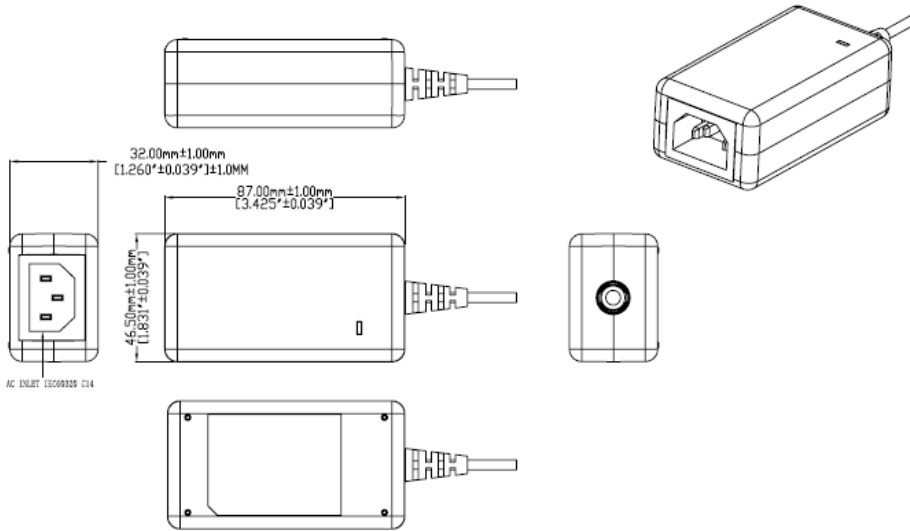

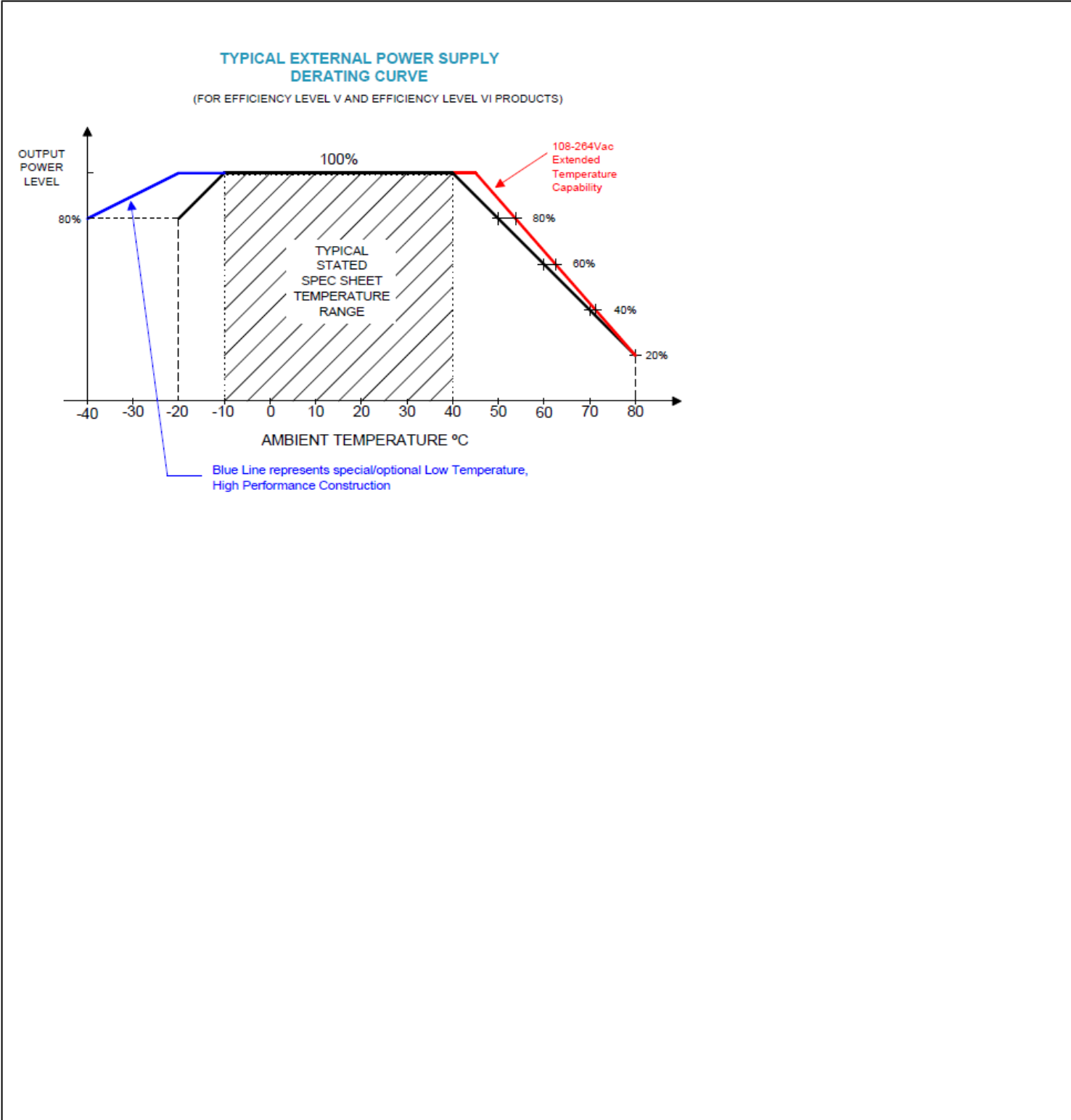

DERATING CURVE

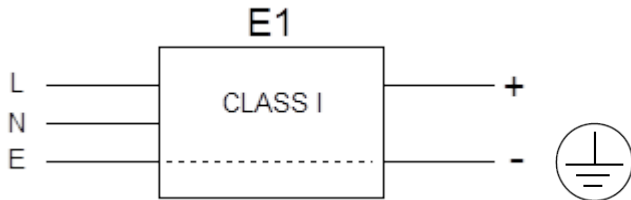
