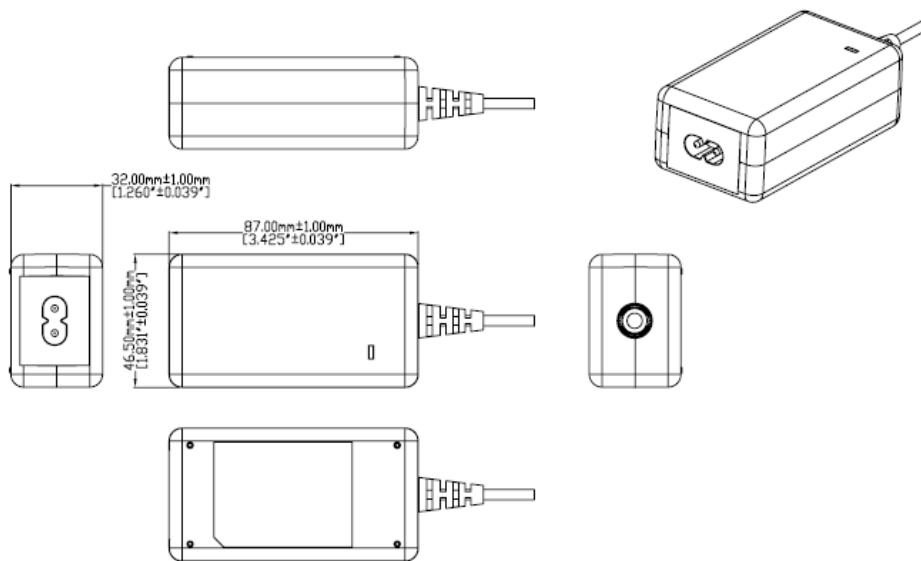

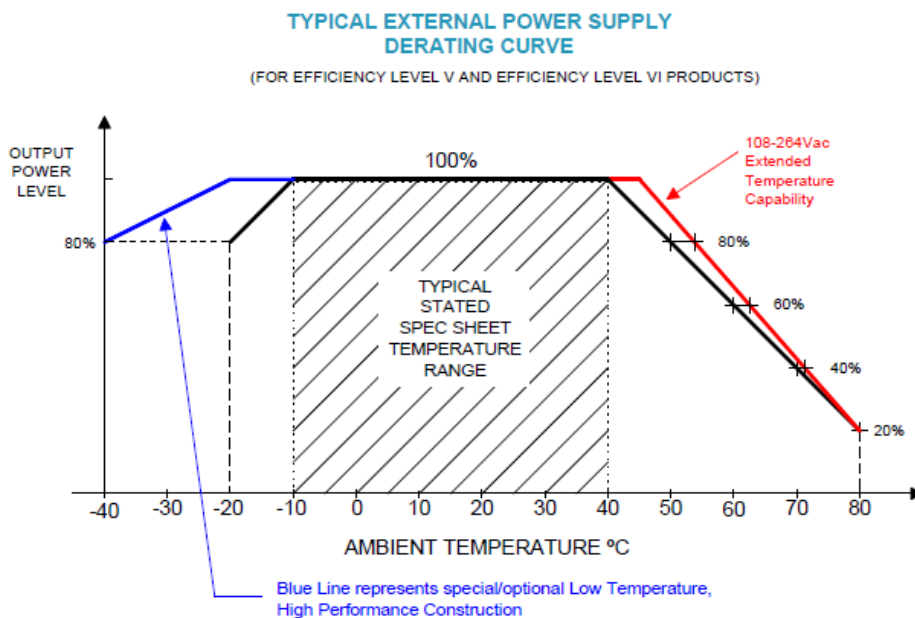

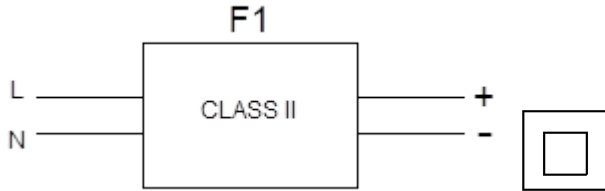
DERATING CURVE

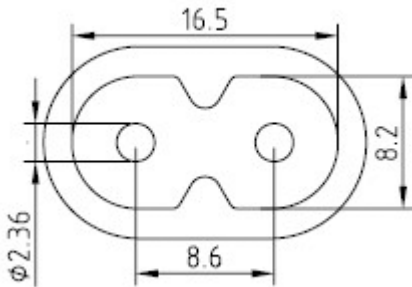

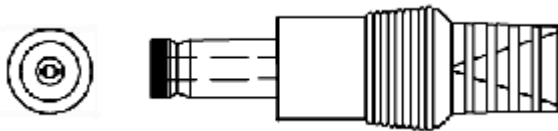


